REQUEST FOR ARRANGEMENT OF NECESSARY ADDITIONAL FUNDS FOR RESTORATION OF DAMAGES TO CANAL BRANCH DISTRIBUTARIES & MINORS IN SOUTHERN DADU DIVISION DADU.

I am directed to refer to the subject noted above and to state that Chief Engineer Right Bank Region Larkana under his Letter No.B/RBR/Demand of Funds /M&R Canal/2021-22/2B/159 dated 2-2-2023 has reported that due to heavy rain fallen in whole Sindh Province and heavy flood quantum water traveled from Balochistan through F.P Bund, then Suprio Bund. The flood water entered so many areas of District Qamber, Shahdadkot, Larkana, Dadu & Sehwan and badly damaged Irrigation network / infrastructure. Due to heavy pressure of flood water Johi Branch has occurred relief cuts on different points for reducing pressure of water all the channels below RD 77.0 are remain under flood water at about one month. All the channels, Johi branch and Dadu Canal are badly damaged and are not in flowing position, their inspection path back berms and banks are also worst condition / damaged and silted with earth in their bed, which seems there not a shape of channels, also on other wheat cultivation season is on head.

2. In this regard, the Chief Engineer Sukkur Barrage Right Bank Region Larkana requested for providing the funds to tune of Rs.350.000 million under following head of account to restore these channels and can be brought on their normal condition for flowing the water by carrying out the works through earth moving machinery on emergent basis, in Southern Dadu Division Dadu.
