
How to create an ADC payment for Income Tax, Sales Tax or FED and pay it online through any bank.

1. Go to any browser and in URL box type https://e.fbr.gov.pk/ and press enter button




- 2. Go to e-Payments Menu and select the payment type as shown in Image:01 above

- 4. A new payment creation form will appear as shown in the Image:02 below





8. Fill the complete form as shown below, make sure to provide your active and correct email address and mobile number. Now press "Create" button from the bottom of the form as shown in below Image:05






